Presidential Primary Voting Starts Today

In-person absentee voting begins on Thursday, January 16, 2020 at every county voter registration office. If you are unable to vote on election day, March 3, 2020, because you will be out of town, have a disability or illness, you may vote beginning Thursday. Though you need only one, these are some of the twenty reasons (shown below) that qualify you to vote in-person absentee or by mail in any Virginia election.

"This election will help determine the Democratic Party nominee for President," said Robert Bennett, Chair of the Lancaster County Democratic Committee. "A friend who has always voted Republican but now is dissatisfied with our President, asked me if he could vote in the Democratic Primary." The answer is 'yes', because primaries in Virginia are open to all registered voters. "This means that voters do not have to be registered as a Democrat, Republican, or Independent to vote in the Democratic Presidential Primary election," explained Bennett.

To vote in-person absentee, no appointment is needed; simply bring your current photo ID to your county registration office. Absentee voting by mail may be requested at the county voter registration office or online at www.elections.virginia.gov, where you may also register as a new voter or update your current voter registration. The deadline to register or update your registration is February 10, 2020 for the Presidential Primary

Registered voters who vote in-person absentee are subject to the same proof of identification requirements as voting at the polls: you must have a photo ID. Acceptable forms of ID include

- 1. Valid Virginia driver's license;
- 2. Valid United States passport;
- 3. Any other photo identification issued by the Commonwealth, one of its political subdivisions (cities, towns, or counties), or the United States;
- 4. Any valid student identification card containing a photograph of the voter and issued by any institution of higher education located in the Commonwealth or any private school located in the Commonwealth;
- 5. Any valid employee identification card containing a photograph of the voter and issued by an employer of the voter in the ordinary course of the employer's business.

Any registered voter without an acceptable photo ID may apply for a free Virginia Voter Photo Identification from the voter registration office.

Lancaster County and Northumberland County voters will choose their Democratic nominee for President between the following as listed on the ballot: Cory Booker, Julian Castro, Bernie Sanders, Elizabeth Warren, Marianne Williamson, Michael Bennet, Joseph R. Biden, Amy Klobuchar, Tulsi Gabbard, Deval Patrick, Pete Buttigieg, Andrew Yang, Tom Steyer, and Michael R. Bloomberg. As of January 10, the one candidate who is on the ballot but has withdrawn is Julian Castro.
